### PRIVACY DISCLOSURES FOR CALIFORNIA RESIDENTS

These disclosures supplement the Privacy Policy (the "<u>Policy</u>") of Axiscor, L.P., a Delaware limited partnership, ("<u>Axiscor</u>"), which can be found at <u>www.axisor.com</u>, (a "<u>Site</u>"). They are provided pursuant to the California Consumer Privacy Act (the "<u>CCPA</u>") and apply only to residents of California. Each capitalized term used, but not defined, in these disclosures shall have the meaning given to such term in the CCPA.

# **Required Disclosures**

### Categories of Personal Information Collected

The following categories of personal information are collected by Axiscor:

- Identifiers (e.g. name, Internet protocol address, email address, physical address, phone number, and human resources data relating to employees of Axiscor or individuals applying to Axiscor for employment);
- Internet and Network Activity Information; and
- Commercial Information.

#### Categories of Sources of Personal Information Collected

Axiscor obtains categories of personal information from consumers using a Site, third parties using a Site acting on behalf of consumers, or third parties with whom or which Axiscor has a business relationship.

#### Purposes for Collecting Personal Information

Axiscor uses personal information collected by it for one or more of the following purposes:

- To achieve the purposes for which you, a third party acting on your behalf or a third party with whom or which Axiscor has a business relationship provided personal information (e.g. if you provide personal information to request a price quote, ask a question about Axiscor's products or services, or order products or services, Axiscor will use that information to respond to your inquiry or fulfill such order);
- To fulfill orders for products or services, or to process returns of products;
- To provide you with support, and to respond to your questions, regarding products and services of Axiscor;
- To send e-mail messages, newsletters and other relevant information;

- To consider consumers for employment or employ consumers;
- To respond to requests from law enforcement or other governmental authorities;
- To comply with any applicable law or legal obligation;
- To prosecute or defend itself in a legal dispute or proceeding; and
- For any other business purpose permitted by the CCPA.

# Categories of Third Parties with whom Axiscor Shares Personal Information

Axiscor shares personal information with categories of third parties only to enable Axiscor to achieve the purposes for which it collects personal information. In particular, Axiscor shares personal information with its vendors and suppliers. Axiscor does not, however, sell any personal information to third parties.

#### Specific Pieces of Personal Data Collected

Axiscor collects the following specific pieces of personal information:

- Names;
- E-mail addresses;
- Physical addresses; and
- Phone numbers.

#### **Summary of Consumers' Rights**

The following is a summary of a consumer's rights under the CCPA:

# Access to Specific Information and Data Portability Rights

You have the right to request that Axiscor disclose certain information to you regarding your personal information collected by Axiscor as follows:

- The categories of personal information collected about you;
- The categories of sources of the personal information collected about you;
- Axiscor's business or commercial purpose for collecting or, if applicable, sharing your personal information;

- The categories of third parties with which or whom Axiscor shares your personal information;
- The specific pieces of personal information collected about you; and
- If Axiscor disclosed your personal information for a business purpose, a list of such disclosures, identifying the personal information categories that each category of recipient obtained.

#### **Deletion Rights**

You may request that Axiscor delete any of your personal information retained by Axiscor, subject to certain exceptions. Upon receiving and confirming your verifiable consumer request, if an exception does not apply, Axiscor will delete (and direct its service providers to delete) such personal information from Axiscor's (or such service providers') records.

# Verifiable Consumer Requests

To exercise your rights described in these disclosures, you must submit a verifiable consumer request to Axiscor as set forth in the Policy. Only you, or a person registered with the California Secretary of State that you authorize to act on your behalf, may make a verifiable consumer request relating to your personal information. You may also make a verifiable consumer request on behalf of your minor child.

You may only make a verifiable consumer request for access or data portability twice within a 12-month period. The verifiable consumer request must:

- Provide sufficient information that allows Axiscor to reasonably determine you are the
  person about whom Axiscor collected personal information or an authorized
  representative.
- Describe your request with sufficient detail that allows Axiscor to properly understand, evaluate, and respond to it.

Axiscor cannot respond to your request or provide you with personal information if it cannot verify your identity or authority to make the request and confirm the personal information relates to you. Axiscor will only use personal information provided in a verifiable consumer request to verify the requestor's identity or authority to make the request.

#### Axiscor's Response

Axiscor endeavors to respond to a verifiable consumer request within 45 days of its receipt. If Axiscor requires more time (up to an additional 45 days), Axiscor will inform you of the reason and extension period in writing. Axiscor will deliver its written response by mail or electronically, at your option. Any disclosures provided by Axiscor will only cover the 12-month period preceding receipt of the verifiable consumer request. The response provided by Axiscor will, if applicable, also explain the

reasons it cannot comply with a request. For data portability requests, Axiscor will select a format to provide your personal information that is readily useable and should allow you to electronically transmit the information from one entity to another entity without hindrance.

Axiscor does not charge a fee to process or respond to your verifiable consumer request unless it is excessive, repetitive, or manifestly unfounded. If Axiscor determines that any request warrants a fee, it will tell you why a fee is warranted and provide you with a cost estimate before completing your

request.

No Discrimination

Axiscor will not discriminate against you for exercising any rights under the CCPA. In particular, if you exercise any such rights, Axiscor will not:

• Deny you goods or services;

 Charge you different prices or rates for goods or services, including through granting discounts or other benefits, or imposing penalties;

• Provide you a different level or quality of goods or services; or

Suggest that you may receive a different price or rate for goods or services, or a different

level or quality of goods or services.

However, Axiscor may offer you certain financial incentives permitted by the CCPA that can result in different prices, rates, or quality levels. Any such financial incentives offered by Axiscor will reasonably relate to your personal information's value and contain written terms that describe the material aspects of such financial incentives. Your prior opt-in consent, which you may revoke at any

time, is required before you obtain such financial incentives.

Revisions

Axiscor may revise these disclosures from time to time by posting the revisions on a Site. Any such revision will take effect immediately upon such posting, but will only relate to personal information collected after such revision is posted. It is your responsibility to periodically check each Site for

revisions to these disclosures.
