Axiscor Performance Flooring

The limited warranties set forth below apply only to Axiscor Performance Flooring products and are effective with purchases made after April 1, 2022. All warranties are limited to the original purchaser only and the original installation site and are not transferable.

WEAR WARRANTY

Axiscor Performance Flooring warrants that the installed product will not wear through to the printed film layer, stain or fade under normal use within the amount of time specified in the Wear Warranty Chart (see below), or as long as the original purchaser owns the floor, whichever is less. This Wear Warranty excludes any damages resulting from, caused by or contributed to, in any way, improper environmental conditions, indentations, scratches, lack of proper maintenance, use of unauthorized cleaning products, misuse, negligence, accidents, spiked/high heeled shoes, shoes not under proper repair, standing water beyond 72 hours, fire, erosion, pebbles, sand, other abrasives, and/or failure to protect the flooring material during move-in and/or other construction activities in the immediate/adjacent area. Loss of gloss is not a warranted issue.

MATERIAL WARRANTY

Axiscor Performance Flooring warrants that the products have been manufactured in compliance with the grading rules of Axiscor Flooring, and will be free from manufacturing defects for as long as the original purchaser owns the floor.

EXCLUSIONS AND LIMITATIONS

These warranties do not cover damage caused by improper environmental conditions, indentations, scratches, lack of proper maintenance, use of unauthorized cleaning products, misuse, negligence, accidents, spiked/high heeled shoes, shoes not under proper repair, standing water beyond 72 hours, fire, erosion, pebbles, sand, other abrasives, and/or failure to protect the flooring material during move-in and/or other construction activities, indentations or damage caused by vacuum cleaner beater bars, rolling loads (i.e. wheelchairs, hospital beds, etc.), caster wheels, furniture without proper floor protectors or rests, dropping of metal or heavy objects, cuts, gouges, indentations, punctures caused by sharp objects, damage from mold due to prolonged exposure to moisture, or any damage caused when the flooring is exposed to extreme cold (beneath 0°F/-15°C) and/or extreme heat (above 140°F/60°C). Loss of gloss is not a warranted issue.

These warranties do not cover damage caused by use of the flooring for purposes other than those for which it was designed; damage caused by disasters such as fire, flood, wind, and lightning; damage during shipment; or any other abuse or misuse by the purchaser.

It is critical that all installations are completed in compliance with the procedures outlined in the Axiscor Performance Flooring installation instructions, which can be found in/on each carton of flooring and/or online at www.axiscor.com. No damage or defects caused by improper installation, inadequate sub-flooring or improper sub-floor preparation or failure to provide a suitable installation environment are covered by this warranty. Failure to install your flooring in accordance with the instructions will void all warranties. Do not install if there are visible defects.

The sole obligation and liability of Axiscor Performance Flooring under our limited warranties is to repair or replace the floor, at Axiscor's option. Only Axiscor floors that were professionally installed will be eligible for labor cost reimbursement. If you installed the floor yourself, we will cover the cost of replacement materials only. (Any and all labor costs must be pre-approved by the Axiscor Performance Flooring Claims Department.).

These warranties EXCLUDE and will not pay consequential or incidental damages associated with any warranty claim. Axiscor Performance Flooring will not pay costs associated with relocation during the repair process such as hotel, meals, or moving and storage of furniture. This limitation does not apply to claims for personal injury. Axiscor Performance Flooring's liability with respect to a claim for any damages arising out of or connected with the sale, purchase, use or performance of any products sold by Axiscor Performance Flooring will in no event exceed the price paid for the product. Some states do not allow limits on warranties, or on remedies for breach in certain transactions. In such states, the limits in this paragraph may not apply.

No warranty is provided for staining or changes in color caused by dyes tracked from carpets, fertilizers, road tar, driveway sealers, oil drippings or other similar materials; or products faded or discolored by sunlight or heat generation. No warranty is provided for variations of color, shade or texture of the floor purchased from those shown on samples, photographs, literature or advertising material.

No warranty coverage is provided for flooring that contains obvious defects of any kind that were installed nonetheless. If,

before installation, you discover any flooring that has obvious defects, please immediately contact the dealer from whom the flooring was purchased and replacement flooring will be provided at no cost.

Only Axiscor Performance Flooring approved cleaning products are appropriate for use on Axiscor Performance Flooring products. Loss of gloss or build-up of dulling film due to lack of maintenance or improper maintenance, dulled by soaps, detergents, harsh chemicals, wax, damage or discoloration from carpet dyes, fertilizers or other chemicals, staining from use of mats not labeled non-staining and/or damage caused by burns, flooding, fires and other accidents are not covered under these warranties.

Any Axiscor Flooring products designated as B grade, cabin grade, tavern grade, closeouts, seconds, off-goods, "as is", factory special and non-standard items is not covered by the above warranties.

UNDER NO CIRCUMSTANCES SHALL AXISCOR PERFORMNACE FLOORING BE LIABLE FOR ANY LOSS OR DAMAGE ARISING FROM THE PURCHASE, USE, OR INABILITY TO USE THIS PRODUCT, FOR ANY SPECIAL, INDIRECT, INCIDENTAL OR CONSEQUENTIAL DAMAGES. SOME STATES DO NOT ALLOW LIMITATIONS ON HOW LONG AN IMPLIED WARRANTY LASTS, OR THE EXCLUSION OR LIMITATION OF INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE LIMITATIONS MAY NOT APPLY TO YOU. THIS WARRANTY GIVES YOU SPECIFIC LEGAL RIGHTS. YOU MAY ALSO HAVE OTHER RIGHTS WHICH VARY FROM STATE TO STATE. YOUR RIGHTS AND THE LIMITATIONS DESCRIBED ABOVE VARY FROM STATE TO STATE. THUS, IT IS IMPORTANT TO RETAIN THIS WARRANTY INFORMATION. NO INSTALLER, RETAILER, DISTRIBUTOR, AGENT, OR EMPLOYEE OF AXISCOR PERFORANCE FLOORING HAS THE AUTHORITY TO INCREASE OR ALTER THE OBLIGATIONS OR LIMITATIONS OF THIS WARRANTY.

HANDLING OF CLAIMS UNDER THIS WARRANTY Claims must be filed within the coverage period, and information verifying the date of purchase may be required. Axiscor Performance Flooring reserves the right to have a designated Axiscor representative and/or a third-party, independent inspector to inspect the floors and remove samples for technical analysis.
